Remarks (if any):

The Company granted a total of 20,000,000 share options on 27 January 2014 under the share option scheme adopted by the Company on 13 October 2010 (the "Share Option Scheme"). 50% of the share options may be exercised within the period from 27 January 2016 to 26 January 2017 and the remaining 50% of the share options may be exercised within the period from 27 January 2017 to 26 January 2018. On 18 July 2017, the Company further granted 15,000,000 share options under Share Option Scheme - (i) 30% of the share options are exercisable from 18 July 2018 to 17 July 2019; (ii) another 30% of the share options are exercisable from 18 July 2019 to 17 July 2020; and (iii) the remaining 30% of the share options are exercisable from 18 July 2020 to 17 July 2021. Details of the grant of Share Options are set out in the announcements of the Company dated 27 January 2014 and 18 July 2017.
