10,000,000 share options granted on 27 January 2014 under the share option scheme adopted by the Company on 13 October 2010 (the “Share Option Scheme”) were lapsed on 26 January 2018, being the end date of exercise period. On 18 July 2017, the Company granted 15,000,000 share options under Share Option Scheme - (i) 30% of the share options are exercisable from 18 July 2018 to 17 July 2019; (ii) another 30% of the share options are exercisable from 18 July 2019 to 17 July 2020; and (iii) the remaining 30% of the share options are exercisable from 18 July 2020 to 17 July 2021. Details of the grant of Share Options are set out in the announcements of the Company dated 27 January 2014 and 18 July 2017.
