(ii) another 30% of the share options are exercisable from 18 July 2019 to 17 July 2020; and

(iii) the remaining 30% of the share options are exercisable from 18 July 2020 to 17 July 2021.

18 July 2017. On 12 July 2018, the Company granted 30,000,000 share options under Share

Option Scheme - (i) one-fifth of the Share Options may be exercised within the period from

12 July 2019 to 11 July 2020; (ii) one-fifth of the Share Options may be exercised within the

period from 12 July 2020 to 11 July 2021; (iii) one-fifth of the Share Options may be exercised

within the period from 12 July 2021 to 11 July 2022; (iv) one-fifth of the Share Options may be

exercised within the period from 12 July 2022 to 11 July 2023; and (v) the remaining one-fifth of

the Share Options may be exercised within the period from 12 July 2023 to 11 July 2024.
