- (vi) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue;
- (vii) completion has taken place of the purchase by the issuer of all property shown in the listing document to have been purchased or agreed to be purchased by it and the purchase consideration for all such property has been duly satisfied; and
- (viii) the trust deed/deed poll relating to the debenture, loan stock, notes or bonds has been completed and executed, and particulars thereof, if so required by law, have been filed with the Registrar of Companies.

Remarks (if any):

On 18 July 2017, the Company granted 15,000,000 share options under Share Option Scheme -

(i) One-third of the share options are exercisable from 18 July 2018 to 17 July 2019; (ii) another

one-third of the share options are exercisable from 18 July 2019 to 17 July 2020; and (iii) the

remaining one-third of the share options are exercisable from 18 July 2020 to 17 July 2021.

On 12 July 2018, the Company granted 30,000,000 share options under Share Option Scheme -

Upon acceptance of the grant and subject to the rules of the Share Option Scheme, (i) one-fifth of the share options may be exercised within the period from 12 July 2019 to 11 July 2020; (ii)

one-fifth of the share options may be exercised within the period from 12 July 2020 to 11 July 2021; (iii)

one-fifth of the share options may be exercised within the period from 12 July 2021 to

11 July 2022; (iv) one-fifth of the share options may be exercised within the period from 12 July

2022 to 11 July 2023; and (v) the remaining one-fifth of the share options may be exercised

within the period from 12 July 2023 to 11 July 2024.

Details of the grant of Share Options are set out in the announcements of the Company dated 18 July 2017 and 12 July 2018.
