- (v) all documents required by the Companies (Winding Up and Miscellaneous Provisions) Ordinance to be filed with the Registrar of Companies have been duly filed and that compliance has been made with other legal requirements;
- (vi) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue;
- (vii) completion has taken place of the purchase by the issuer of all property shown in the listing document to have been purchased or agreed to be purchased by it and the purchase consideration for all such property has been duly satisfied; and
- (viii) the trust deed/deed poll relating to the debenture, loan stock, notes or bonds has been completed and executed, and particulars thereof, if so required by law, have been filed with the Registrar of Companies.

Remarks (if any):

On 18 July 2017, the Company granted 15,000,000 share options under the Share Option Scheme - (i) One-third of the share options has been exercised by each of the grantees on 16 July 2019 and 17 July 2019, respectively; (ii) another one-third of the share options has been exercised by each of the grantees on 2 September 2019; (iii) 4,000,000 share options have been exercised by two grantees on 31 July 2020; and (iv) 1,000,000 share options have been lapsed in July 2020. On 12 July 2018, the Company granted 30,000,000 share options under the Share Option Scheme among which, 6,000,000 share options have been lapsed in July 2020. Upon acceptance of the grant and subject to the rules of the Share Option Scheme, (i) one-fifth of the share options may be exercised within the period from 12 July 2020 to 11 July 2021; (ii) one-fifth of the share options may be exercised within the period from 12 July 2021 to 11 July 2022; (iii) one-fifth of the share options may be exercised within the period from 12 July 2022 to 11 July 2023; and (iv) the remaining one-fifth of the share options may be exercised within the period sare set out in the announcements of the Company dated 18 July 2017 and 12 July 2018.
