On 12 July 2018, the Company granted 30,000,000 share options under the Share Option Scheme among which, 6,000,000 share options have been lapsed in July 2020. Upon acceptance of the grant and subject to the rules of the Share Option Scheme, (i) one-fifth of the share options may be exercised within the period from 12 July 2020 to 11 July 2021; (ii) one-fifth of the share options may be exercised within the period from 12 July 2021 to 11 July 2022; (iii) one-fifth of the share share options may be exercised within the period from 12 July 2021 to 11 July 2022; (iii) one-fifth of the share options may be exercised within the period from 12 July 2022 to 11 July 2023; and (iv) the remaining one-fifth of the share options may be exercised within the period sare set out in the announcement of the Company dated 12 July 2018.
