#### Remarks:

On 12 July 2018, the Company granted 30,000,000 share options under the Share Option Scheme adopted on 13 October 2010 among which, 6,000,000 share options have been lapsed in July 2020 and 6,000,000 share options have been lapsed in July 2021. Upon acceptance of the grant and subject to the rules of the Share Option Scheme, (i) one-fifth of the share options may be exercised within the period from 12 July 2021 to 11 July 2022; (ii) one-fifth of the share options may be exercised within the period from 12 July 2022 to 11 July 2023; and (iii) the remaining one-fifth of the share options may be exercised within the period from 12 July 2023 to 11 July 2024.
